Tariff for Cruise Vessels 2026

Mission Statement :

Bodrum Yolcu Limanı İşletmeleri A.Ş. ("Bodrum Cruise Port") is committed to working in partnership with cruise ship operators and our other valued clients.

Our goal is to continue delivering the highest quality cruise port services with an efficient and friendly manner while ensuring your security and safety.

Functional Currency & Validity :

The currency of the port tariff for Cruise Vessels is in **Dollar (\$)** basis. Taking the day of arrival of the ship, the fees will be converted to TL ("Turkish Lira") based on the daily selling exchange rate determined by the Turkish Central Bank ("T.C. Merkez Bankası").

The tariff shall be effective between **01.01.2026** and **31.12.2026** subject to any amendments **Bodrum Cruise Ports ("Port Management")** may announce during the term specified.

The "A, B, C", Three-Tier Discount System

A Three-Tier Discount System (referred to as the 'A, B, C Discount') applies to Shelter and Security fees.

Where applicable, the following discounts will be applied to Shelter and Security fees:

- Per Call Discount
- Per Brand Discount
- Per Corporate Discount

Effective **1st of January 2026**, the three-tier discount will apply to aforementioned ship services fees for cruise ships making multiple calls from the **1st of January to the 31st of December** in any calendar year at the Port.

The head tax fee for passenger traffic services is fixed and not subject to any discount and/or deduction.

The total discount on the aforementioned ship services fees will be the sum of the per call, brand and corporate discounts (where available) as follows:

Total Discount = A (Per Call Discount) + B (Per Brand Discount) + C (Per Corporate Discount)

1. In addition to the “per call” discounts, a cruise ship may be entitled to a brand discount based on the number of calls made from the 1st of January to the 31st of December in any calendar year by all cruise ships deemed to be part of a brand.
2. A cruise ship is deemed to be part of a brand if such ship shares all or a portion of a service mark or trade name with one or other cruise vessels which are operated in common with such cruise ship and which are also calling at the Port from the 1st of January to the 31st of December in the calendar year for which the brand discount is claimed.
3. Entitlement to the brand discount will be determined on the basis of actual use of the service mark or trade name in respect of which the brand discount is claimed.
4. In the event of a dispute as to entitlement to a brand discount hereunder, the determination of the Port shall prevail.

C. Per Corporate Discount

C. Corporate Discount

1. In addition to the “per call” and “brand” discounts, a cruise ship may be entitled to a corporate discount based on the number of calls made from the 1st of January to the 31st of December in any calendar year by all cruise vessels deemed to be part of a corporate group.
2. A cruise ship is deemed to be part of a corporate group if such ship is under direct, indirect or beneficial common ownership with one or more other cruise vessels calling at the Port from the 1st of January to the 31st of December in the calendar year for which the corporate discount is claimed.
3. Entitlement to the corporate discount will be determined on the basis of a notarized copy of a letter from a senior officer, such as chief financial officer or chief legal counsel, of the corporate group for which entitlement to a corporate group discount is claimed.
4. In the event of a dispute as to entitlement to a corporate discount hereunder, the determination of the Port shall prevail.

Main Tariff Schedule

1.1. Landing Fee for Transit Passengers

1. The landing fee is charged per passenger in transit, embarking, disembarking.
2. The landing fee is fixed and not subject to discount and/or deduction.

1.2. Landing Fee for Turn-Around / Home Port Passengers

1. The landing Fee is charged per passenger and for each passenger embarking from our port,
2. The landing Fee is charged per passenger and for each passenger disembarking from our port
3. The landing fee is fixed and not subject to discount.

2. Port Tariff for Ship Services

The fees for Pilotage, Towage, and Line Handling in our tariff have been updated in accordance with the amendment made in the Directive on Fees for Pilotage, Towage, and Line Handling Services, published with the Ministerial Approval dated 19.09.2024 and numbered 2187670. Any future changes made by the Ministry of Transport to the fee regulations will be automatically reflected in our tariff.

The fees for Pilotage, Towage, and Line Handling services will be calculated as double for both berthing and departure maneuvers. The fees are determined based on a 1,000 GRT range, and for vessels of 120,000 GRT and above, the charge is fixed at the 120,000 GRT rate.

2.1. Pilotage

1. The pilotage fee above is valid for one pilot boat any day of the week and is an additional fee of 50% will be applied to state-controlled fees for pilotage, for ships docking at our port during public holidays Standby fee will be charged if a period standby occurs by the fault of the ship's captain, the tour operator or the ship's agent and if the personnel and the equipment which have been positioned further to their request and are not used in the time set and indicated by the parties requesting the services.

- The pilotage standby penalty will be determined as an additional \$750 up to an hour and \$750 per any additional hour above the pilotage service fee, in case of a standby and delay of the services due to this standby.
 - If further to a standby period no services are utilized the standby fee and 50% of the pilotage fee listed on the official port tariff will be applied.
 - If the personnel and pilot boat reach the operational area and return without completing any services 50% of the pilotage fee listed on the official port tariff will be applied.
 - The management of the port is authorized to limit the standby period to a maximum of 2 hours and if necessary to shift the pilotage services to another pilotage request demanded during the standby period.
 - For any other service request to be provided by the Pilot Boat such as taxi, towing, material transfer etc. please contact Bodrum Cruise Port's Management (info@bodrumcruiseport.com) for pricing info.
2. For foreign navy ships, and ships carrying explosives, inflammables, combustibles and toxic materials please contact Bodrum Cruise Port's Management info@bodrumcruiseport.com
 3. The pilotage fee will be charged if ships which are not liable to pilotage charge are requesting the pilotage service.

2.2. Towage (For vessels up to 125 meters (L.O.A))

1. Pursuant to the amended National Ports Regulation (Article 3, Paragraphs 1-2, amending Article 14, Paragraph 5), effective from 17 November 2024, the Port will mandatorily provide Escort Tugboat services for all vessels to enhance maritime safety. This service will be offered at a 50% discounted rate.
2. The Towage Fee above is valid for vessels up to 125 meters(L.O.A) and for one tugboat any day of the week and an additional fee of 50% will be applied to state-controlled fees for tugboat for ships docking at our port during public holidays For vessels greater than or equal to 125 meters (L.O.A), please contact Bodrum Cruise Port's Management info@bodrumcruiseport.com for relevant pricing information.
3. According to current tug boat regulation if the ship authorities declare the documents regarding the bow stern thrusters or system stating that these systems are working with full capacity the ship is not obliged to request towing boats. It is subjected to current regulation on the day of the call.
4. Standby fee will be charged if a period standby occurs by the fault of the ship's captain, the tour operator or the ship's agent and if the personnel and the equipment which have been positioned further to their request and are not used in the time set and indicated by the parties requesting the services.
 - The towage standby penalty will be determined as an additional \$1,500 up to an hour and \$1,500 per any additional hour above the towage service fee, in case of a standby and delay of the services due to this standby.
 - If further to a standby period no services are utilized the standby fee and 50% of the towage fee listed on the official port tariff will be applied.
 - If the personnel and tugboat reach the operational area and return without completing any services 50% of the towage fee listed on the official port tariff will be applied.
 - The management of the port is authorized to limit the standby period to a maximum of 2 hours and if necessary to shift the towage services to another towage request demanded during the standby period.
1. For foreign navy ships, any other ships carrying explosives, inflammables, combustibles and toxic materials, ships requesting extra cautionary towing services while docked at the berth due to heavy weather conditions etc. please contact Bodrum Cruise Port's Management info@bodrumcruiseport.com for pricing information.

2. The towage fee will be charged if ships which are not liable to towage charge are requesting the towage services.

2.3. Mooring (Line-Handling)

1. The mooring fee includes the mooring and unmooring services and will be charged at double the standard rate for both berthing and departure maneuvers.
2. The mooring fee above is valid for any day of the week and an additional fee of 50% will be applied to state-controlled fees for mooring services for ships docking at our port during public holidays.
3. Standby fee will be charged if a period standby occurs by the fault of the ship's captain, the tour operator or the ship's agent and if the personnel and the equipment which have been positioned further to their request and are not used in the time set and indicated by the parties requesting the services.
 - The mooring standby penalty will be determined as an additional \$300 up to an hour and \$300 per any additional hour above the mooring service fee, in case of a standby and delay of the services due to this standby.
 - If further to a standby period no services are utilized the standby fee and 50% of the mooring fee listed on the official port tariff will be applied
 - If the personnel reach the operational area and return without completing any services 50% of the mooring fee listed on the official port tariff will be applied.
 - The management of the port is authorized to limit the standby period to a maximum of 2 hours and if necessary to shift the mooring services to another mooring request demanded during the standby period.
